

# Professional Standards Tracker Log for School Nutrition Programs

The U.S. Department of Agriculture (USDA) requires school food authorities (SFAs) to maintain documentation of professional development activities (such as trainings, workshops, and conferences) for all staff whose responsibilities include duties related to the operation of the [school nutrition programs](#), including school food service personnel and non-school food service personnel. For example, teachers and other applicable personnel who conduct [classroom meal counts](#) or [field trip meal counts](#) must receive appropriate training to ensure they perform their jobs effectively and in compliance with the USDA's regulations.

## Maintain Training Records on File

During the [Administrative Review of the school nutrition programs](#), the Connecticut State Department of Education (CSDE) will review the SFA's records that document the completion of annual training standards by all personnel (program directors, managers, and staff). Training certificates, training sign-in sheets, and training agendas are examples of documents that SFAs may submit to demonstrate compliance with the training standards. Reports from the USDA Training Tracking Tool (or similar alternative training tracking tool) that demonstrate compliance with the training standards are also examples of possible documentation.

SFAs may use the CSDE's *Professional Standards Tracker Log for School Nutrition Programs* Excel worksheet to maintain records of each school food service employee's completion of the annual training standards.
